Workshop Description: Attendees will be taken from basic to advanced review of understanding diagnostic imaging.

Hour 1 **Missed Radiographic Findings**

Attendees will learn about the importance of search patterns for film review. Attendees will also learn about different ways that a doctor may miss a finding: errors of perception and errors of cognition.

Hour 2 **Radiology Case Studies In Chiropractic**

Attendees will be exposed to multiple type of pathologies and imaging studies of various body regions, from cases pulled from chiropractic practices.

Hour 3-4 **Surprises In Chiropractic Radiology**

Attendees will learn that even though patient history is an important part of process in diagnosing a patients condition, sometimes obtaining imaging will uncover un-expected or additional important findings.

Hour 5 **Upper Cervical Anomalies**

Review of not so common anomalies of the upper cervical spine and the association with central nervous system anomalies, such as Chiari malformation.

Hour 6 **Adolescent Spondylolysis And Spondylolisthesis**

The quiet epidemic of overuse injuries in the spines of athletes. Discussion of diagnosis and management.

Hour 7 **Lumbar Disc Classification And Nomenclature**

The quiet epidemic of overuse injuries in the spines of athletes. Discussion of diagnosis and management.

Hour 8 **Lumbar Instability**

Discussion on the concepts of spinal intersegmental instability and how to determine when instability is present.
