**Workshop Title:** *An Evidence-Based Approach To The Evaluation Of Rehabilitative Exercise Within A Chiropractic Setting*

**Workshop Description:** This presentation will provide a review of the evidence, definitions and medical necessity for therapeutic exercise and how to address the key issues associated with the supervision of rehabilitative exercise.

- + Summarize the research evidence for the clinical effectiveness and rationales for the use of general exercise, motor-control exercise and spinal stabilization exercise programs.
- + Describe the key components of medical necessity for a "skilled service" as it relates to therapeutic exercise interventions.
- + Differentiate the clinical circumstances under which group exercise versus one-on-one supervised exercise programs are indicated.
- + Provide an overview of the clinical findings that substantiate the need for supervised therapeutic exercise, and how re-assessments are used to modify the exercise intervention over time.
